DECLARATION OF	ALEXANDER ROUBIAN

ALEXANDER ROUBIAN hereby certifies, verifies and declares as follows:

1. I am one of the named Plaintiffs in this matter.

- I have read all of the factual allegations of this Verified Complaint and Jury Demand and have reviewed all exhibits attached thereto, and all factual allegations are true and all "Exhibits" attached are true copies of the originals.
- I hereby supplement the and expand upon the factual information contained in the Verified Complaint and Jury Demand and attach hereto the following Exhibits which are true copies of the originals as follows:
 - **"Exhibit A":** Copy of "2020 New Jersey Police Press Credentials CRITERIA" article found on Defendant New Jersey Press Association's web page www.njpa.org which explains the standards and eligibility and application process to apply for "New Jersey Police Press Credentials". (3 pages).
 - **"Exhibit B":** Copy of standard "APPLICATION for 2020 New Jersey Police Press Credentials" found on Defendant New Jersey Press Association's web page www.nipa.org. (3 pages)
 - "Exhibit C": Copy of emails between me and Peg Arbitell, Business Manager of Defendant New Jersey Press Association from May 18, 21 and 23 of 2019 confirming denial of my application for New Jersey Police Credentials and confirming that there is no appeal procedure. (5 pages)
 - **"Exhibit D":** Copy of April 4 & 5 2019 emails between me and Sargent Brian Murray, New Jersey State Police denying my request for an "Governors Office Press Pass" (2 pages).
 - "Exhibit E": Copy of letter dated April 25, 2019 (emailed to me April 24, 2019) from the Office of the Governor formally responding to an Open Public Records Act request I had made (1 page) confirming that there are no written "... records of the policy or policies provided by the Governor's office governing issuing of press passes" and therefore no appeal procedure (1 page).
 - "Exhibit F": Copy of letter dated October 23, 2019 from the Office of the Governor formally responding to an Open Public Records Act request I had made (2 pages) attaching the list of names of the 61 persons as of that date who had been issued "Governor's Office Press Pass" (1 page) and documents from recent applicants (24 pages).

- 4. As previously pointed out, I am the President of plaintiff New Jersey Second Amendment Society. In addition to such duties as President I am also a reporter and journalist for the news and information portion of the societies webpage found at www.nj2a.org. In such capacity I have for a long time routinely attended press conferences held by the current and past Governors of New Jersey notwithstanding being denied so-called "Press Credentials" or "Press Pass".
- 5. I previously applied to Defendant New Jersey Press Association ("NJPA") for so-called "New Jersey Police Press Credentials". The New Jersey Police Press Credential program is administered by an NJPA on behalf of state entities and state actors the New Jersey State Police and the New Jersey Association of Police Chiefs. The stated sole purpose of these "Credentials" is to aid police officers and other emergency personnel at active police or fire scenes in identifying those who are professional news reporters and photographers having a claimed need and constitutional right for access to police and fire scenes in connection with their professional news gathering duties. NJPA (on behalf of the New Jersey State Police and New Jersey Association of Police Chiefs) makes clear and emphasizes that a New Jersey Police Press Credential is not required nor intended for use related to anyone covering municipal, county or state government meetings. Attached as "Exhibit A" is a printout from the NJPA website explaining the criteria and application process. Attached as "Exhibit B" is the standard form application (blank) for such credentials. I indeed applied for such credentials in May 2018 and that same month my request was arbitrarily denied by the NJPA with me simply being informally told that I"... do not need them..." because I"... do not cover breaking news." This is simply not true as any issue involving Second Amendment Rights is routinely covered, often in real

time, by me or other representatives of the New Jersey Second Amendment Society. The NJPA never gave me any written specification of reasons for the denial, I was never given notice that I had a right to appeal the denial, and in fact there is no appeals process or forum to appeal the denial to. *See* "Exhibit C".

6. At some point approximately one year ago in April 2019, I learned that Gov. Murphy and his office had implemented a policy whereby they would issue a new "Governor's Office Press Pass". I immediately "applied" through the New Jersey State Police as I was told to do (the process was informal) and was almost immediately rejected by the Governors Communication Office with them claiming that I do not represent a "media outlet" which of course is false and absurd. Again, there was no right to appeal, no written specification explaining the denial, and no forum to appeal to. When I complained to the state police were I originally applied I was advised by Sgt. Brian J. Murray by April 4, 2019 email as follows: "Alex, I am just the middle man in this. This was the policy put in place when the Murphy administration took over. If you have any further questions contact the Governor's Communication office and they can explain their policy in further detail". I responded the same day by email back to Sgt. Murray as follows: "Hi Brian, I understand. Can you please send me a copy of the policy so that I can ensure that I comply with it? The next day, April 4, 2019, Sgt. Brian J Murray responded back to me as follows: "Alex, As I wrote in the previous email. This policy was only passed down to me from the Gov.'s office as far as how press Ids will be handled. I don't have any further information to provide you which is why I directed you to contact the Gov.'s


- office directly so they could possibly assist you further." See "Exhibit D". I thereafter attempted to contact the Governor's Communications Office but they simply ignored me.
- 7. After being ignored, about a week later I filed a request with the Governor's Office under the New Jersey Open Public Records Act (OPRA) specifically demanding any and all records regarding the policy or policies provided by the Gov.'s office governing the issuance of press passes. By letter dated April 25, 2019 I was formally advised by the Governor's Office in relevant part as follows: "please be advised that no responsive records were located. To assist you, however, it is my understanding that press passes are only issued by our office to official media outlets." (Emphasis added). See "Exhibit E". As there is no policy written or otherwise the actual "policy" and matter of determining what constitutes an "official media outlet" is strictly up to the subjective whims of the Governor's Office who quite clearly summarily reject any media news and information outlet that disagrees with and does not favorably report on the Governor such as Plaintiff New Jersey Second Amendment Society, and by taking such action the Governor is essentially illegally and unconstitutionally silencing his critics.
- 8. Attached as "Exhibit F" is an October 23, 2019 response from the Governor's Office responding to another request from me under New Jersey's OPRA wherein I had requested a list of those who have been issued Governor's Press Passes and a list of applications. Significantly, my application is missing and this confirms that Governor's Office Press Passes have routinely been issued to media outlets equal to or much lesser insignificance and reader follow thing than Plaintiff New Jersey Second Amendment Society.

9. Notwithstanding my not having either of the two forms of "Press Credentials" issued by the state of New Jersey, I nevertheless routinely attended the Daily Governors and CTF public briefings without issue. However, once Plaintiff New Jersey Second Amendment Society sued the Governor in Federal Court over his failure to include Gun and Ammunition Stores on the list of "Essential Businesses", within a few days thereafter and specifically beginning on March 28, 2020 I was barred entrance by two armed state troopers Defendants John Does 1-20 and specifically told that because I did not have "Press Credentials" (which I was clearly legally and constitutionally entitled to) that I would no longer be allowed the right or privilege to attend the daily briefings or any other briefings. Almost simultaneously there to my access through the Internet to the Governors Public Daily Schedule and schedule public appearances on the website portal was blocked. When I could not obtain access I confirmed that I was intentionally blocked and would no longer be given access. This information and the web portal are open to anyone who supplies their name and email address. No other information is needed and no request is made as to whether the applicant is media. All of the foregoing is in retaliation for reporting unfavorably about certain actions of the Governor and pursuing the Governor in Federal Court.

I DECLARE UNDER THE PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT.



Alexander – I understand your frustration when it comes to trying to gain access to political events, government meetings, etc. The individuals who are denying you access must not understand the purpose of the NJ police press credential, and should not be denying you access to cover such events.

When the program was initialized, it was on behalf of the state and local police to try and aide them when there is a crime scene or breaking news event that identify a full time reporter or photographer working for a **news organization** who was trying to gain access beyond the yellow police tape/line. Even at these types of situations, it is still the final decision of the police and EMT officials whether crossing that police/fire line would interfere with their investigation. The NJ Press Association along with the NJ State Police and NJ Police Chiefs Association many years ago created the criteria together to help aide in these types of situations. These are working guidelines, there aren't any statues. As stated before, these credentials are not meant to be used for political events, sporting events, government or town hall meetings, entertainment access, etc. In addition, your organization is a civil advocacy group with a targeted topic/audience and is not considered a **news organization covering news of a general nature**.

I would be happy to speak to those who are denying you such access if it happens again and explain to them what these credentials are to be used for and that if you presented them with your own company ID, that should be sufficient enough for them to allow you access to the type of government events you are trying to cover. If they still deny you access, unfortunately, that is something that you would have to work out with them directly.

You may also want to show them a copy of the criteria below if that helps.

Of course, it is harder to get to the truth if you don't have access to the place where the news is occurring. Right or wrong, government officials seem to be under the impression that your press credential is required in some cases, so here I am, attempting to comply in good faith.
